


Step 1: Sign In to UW CME Portal, https://uw.cloud-cme.com/default.aspx.



If you do not have a UWCloudCME account, click on the **Sign in or Create Account** button then **Create New Account**




Once you have logged in to your account you will be prompted to complete your profile. Click **OK** and complete the registration.




Please complete the profile with as much accurate information. You will need to answer all required questions in red before you can hit submit.


Step 2: You will see your name on the top right once logged on successfully.
